Annual NS Bluegrass and Oldtime Music Festival Presenter: John Simms, Chair

Mr. Simms appeared before Council to request a Community Events Grant in the amount of \$10,000 for the upcoming NS Bluegrass and Oldtime Music Festival which will be held from July 22-28, 2019.

Included in the presentation was a description of the Festival as well as the Downeast Bluegrass and Oldtime Music Society; Festival financial statements and a budget for this year's event; examples of the Festival's economic development contributions and how the Festival's location is determined.

Discussion was held on the reason why the Community Events Grants was needed this year. Mr. Simms explained that the rental fee for the NSPE grounds increased from \$13,000 + tax in previous years to \$22,000 + tax this year. Suggestions were made on other locations within the County where the Festival could be held. Mr. Simms reminded Council that the location is decided by a Board of Directors vote and with only 2 Board members from the Colchester area, a change of location will most likely mean the festival would move back to Hants or Annapolis County.

NS Fire Dispatch Standards Presenter: Terry Canning

Mr. Canning appeared before Council to present the Fire Service Association of NS (FSANS) Fire Dispatch Standards and to request that the County adopt and endorse these standards.

Included in the presentation was a background on the NS Fire Dispatch Standards Committee and their Terms of Reference; the current state of NS Fire Dispatch; and the benefits of adopting a set of standards. Discussion was held on how many facilities in the province meet the standards the FSANS are proposing. Mr. Canning informed Council that there are currently no facilities in Nova Scotia that meet the FSANS standards.
